



Reasons

- The proposed development does not meet the requirements of Section 3.4.19 of the 1998 South Dublin County Development plan which requires a minimum of 2.3 metres separation between the flank walls of each house.
- Minimum setback of 2 metres between the wall of the proposed house and the back of the public pathway has not been provided for. As such the proposal would constitute substandard development contrary to the proper planning and development of the area.
- Adequate information in relation to drainage and water arrangements on site has not been submitted and as such sufficient information is not available in order to make a satisfactory assessment of the drainage/water implications of the proposed development. A grant of planning permission would therefore be prejudicial to public health.
