

APPEAL by Max Pallet Services Limited of Unit 1, Colemanstown, Rathcoole, County Dublin against the decision made on the 10th day of February, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the retention of roofing-in of a storage area and two portacabins at Colemanstown, Rathcoole, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. It is considered that the development proposed to be retained results in an intensification of use leading to an increase in traffic-turning movements which the development generates on the National Primary Route (N7) and, having regard to the substandard nature of Colemanstown Lane and its junction with the N7, the development would adversely affect the use of a National Primary Route (N7) and would, therefore, endanger public safety by reason of traffic hazard and obstruction of road users.
- 2. The development to be retained, by itself and by the precedent which a grant of permission for it would set for other development, would adversely affect the use of a National Road by traffic and would, therefore, be contrary to the proper planning and development of the area.
