Reasons

- The house to the side of No. 61 Monksfield Walk is located within 2.5m of a 200mm diameter watermain. No building is permitted to lie within 5m of watermains less than 225mm diameter and within 8m of watermains greater than 225mm diameter. The development is therefore contrary to the proper planning and development of the area and would thus be prejudicial to public health.
- Having regard to the 1.3 metre separation between the existing house No. 61 and the new house to the side, the development would materially contravene a development plan objective of the South Dublin County Council Development plan, 1998, with regard to the separation between dwellings as set out in paragraph 3.4.19 and would thus be contrary to the proper planning and development of the area.
- The proposed development would contravene materially a condition attached to an existing permission for development Reg. Ref. S98A/0801, Condition No. 2 which stated that 'prior to the commencement of development the applicant shall submit revised details for the written agreement of the Planning Authority providing for an amended site layout and house type in the form of a terrace style dwelling attached to the existing dwelling on the site. The development would therefore be contrary to the proper planning and development of the area.
