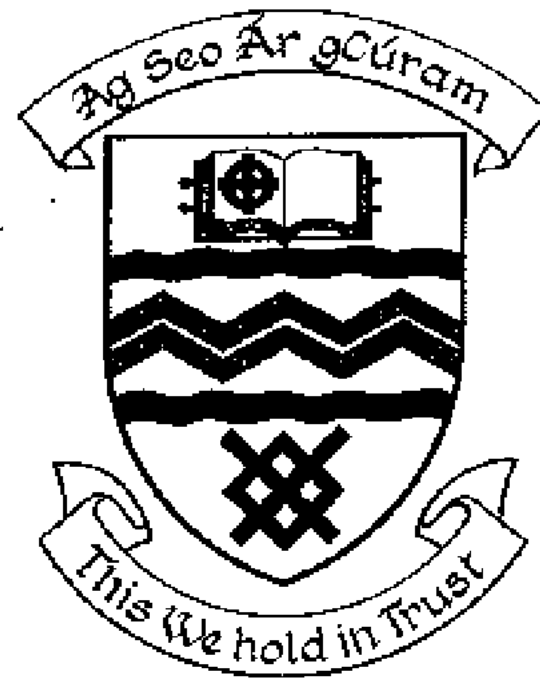

Conditions and Reasons

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:

- 2 That no advertising sign or structure be erected in conjunction with the redevelopment of the site entrance except those which are exempted development, without the prior approval of the Planning Authority.
