Reasons

- Development of the kind proposed on the land would be premature by reference to an existing deficiency in the public foul sewerage facilities in the area.
- The provision of percolation areas in public open space areas is unacceptable to the Planning Authority. The development as proposed would be prejudicial to public health.
- The open space provision is of a type which will not be taken in charge by the Local Authority due to the high maintenance requirements. A grant of planning permission for the development as proposed would be contrary to the proper planning and development of the area.
- It is considered that the layout and design of the proposed development does make full use of the site area available. This is especially so in respect of the large area of land which has been dedicated as private rear garden areas especially at the north western end of the site. The development is considered to be contrary to the provisions of the South Dublin County Development Plan 1998 in respect of the sustainable development of the area and is considered to be contrary to the proper planning and development of the area.
- The proposed development does not meet the requirements of the Development Plan in respect of the provision of off street car parking and does not meet the requirements of the Planning Authority in respect of the provision of vision splays. The development would be contrary to the provisions of the Development Plan and would endanger public safety by way of traffic hazard.
- The proposed development would not accord with Specific Local Objective 36 of the South Dublin County Development Plan which requires that any development in Kingswood Village be structurally and aesthetically to the highest standard.
