



#### Reasons

- The proposed development does not meet the requirements of Section 3.4.16.i of the 1998 South Dublin County Development Plan which requires all houses to have a minimum of 60sq.m. (exclusive of car parking area) of private open space behind the front building line.
- The proposed development does not meet the requirements of Section 3.4.16.i of the 1998 South Dublin County Development plan which requires a minimum standard of 22 metres between directly opposing first floor windows.
- The subject site is zoned 'A', "to protect and/or improve residential amenity". It is considered that the proposed development and its associated features would materially contravene the said zoning objective and would be contrary to the proper planning and development of the area.
- The proposed development would result in overlooking of, and lack of privacy to, neighbouring dwellings to an unreasonable degree. As such the proposed development would seriously injure the amenities and depreciate the value of property in the vicinity.
- The proposal involves the use of combined sewers. This is considered to be unacceptable and prejudicial to public health.
