

Dear Sir/Madam, With reference to your planning application, received on 18/10/99 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:


- The site layout for approval permission does not correspond with that which was granted outline permission. Please submit a revised proposal for the site area that was shown in the outline permission (Reference S98A/0818), so that the boundary division is a straight line, and leaving the indicated carport for no. 352 within No. 352's site curtilage; and also so that the footprint of the house for approval matches that of the outline permission, i.e. the building line does not extend beyond that of No. 352, either to the rear or to the front.
- The applicant is requested to submit revised drawings for the proposed house, so that the proposed house matches the surrounding housing. The roof layout shall be aligned parallel to the road; not in the 'L' shape as proposed, and shall directly correspond with adjoining housing. All external finishes and fenestration shall match the surrounding housing. Brick shall be omitted.

- The applicant is requested to submit a revised site layout plan showing provision for two off-street car parking spaces.
- The applicant is requested to submit full details of proposed drainage, including pipe sizes, invert, cover and invert levels, up to and including connection to public sewer.
- The applicant is requested to establish the distance of the proposed building from a 675mm diameter public sewer that runs along Orwell Park Close. No building shall be within 5m of this sewer. The applicant is requested to submit full details to the Planning Department of South Dublin County Council.
- The applicant is requested to establish the distance of the proposed building from a 100mm diameter public watermain that runs along Orwell Park Close. No building shall be within 5m of this watermain. The applicant is requested to submit full details to the Planning Department of South Dublin County Council.
- The applicant is requested to submit details of proposed watermain layout including watermain size, material, sluice and air valves, meter and hydrants, and proposed point of connection to existing watermain. Layout to be in accordance with Part B of 1997 Building Regulations.
