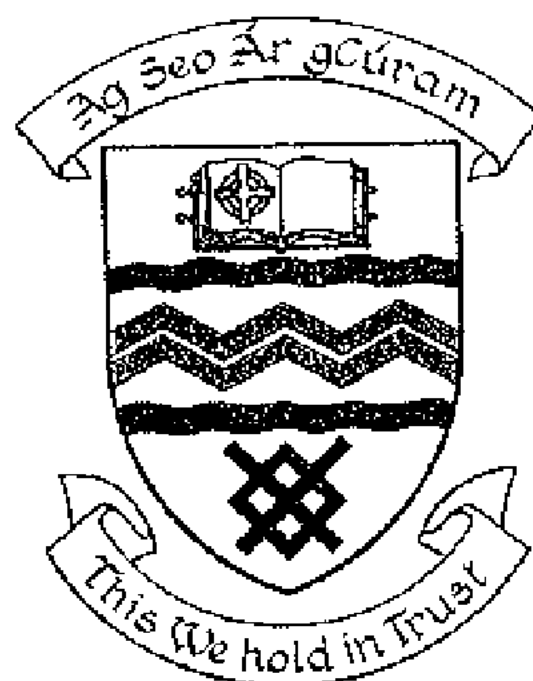

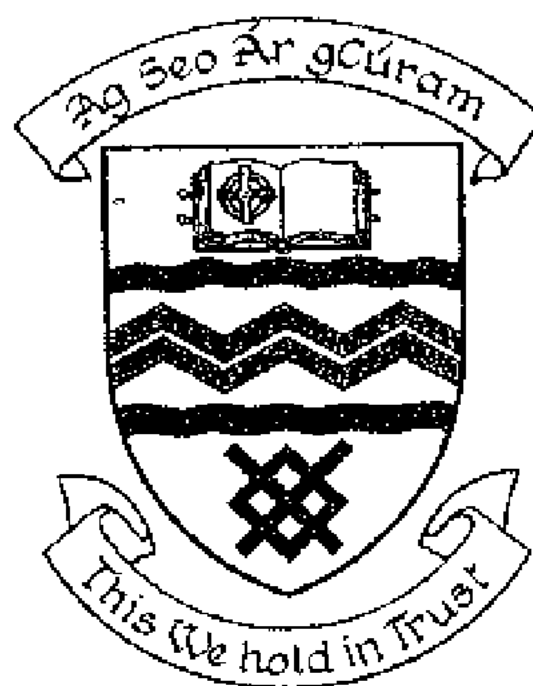

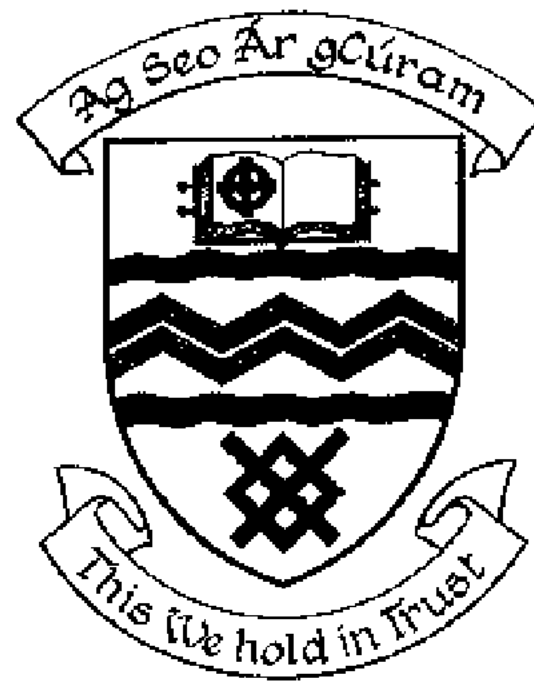
Reasons
