## Reasons

- The size, bulk and scale of the proposed development is considered to be out of character with the locality. The elevated nature of the site combined with the bulk of the proposed development would render the proposed development visually obtrusive at this location. By virtue of the size, bulk, design, proposed materials and range of materials proposed the development would contravene materially the provisions of Appendix D of the South Dublin County Development Plan, 1998 and would materially contravene the use zoning objective of the Development Plan for the area which is to protect and improve rural amenity and to provide for the development of agriculture.
- The proposed development would be prejudicial to public health for the following reasons:-
  - (a) The proposed percolation area does not comply with the requirements of S.R.6 1991.
  - (b) The applicant has failed to carry out trial holes.
- It is noted that the scales and dimensions shown on the block plan are inaccurate and that the proposed access point as shown on the block plan is inadequate as regards vision splays. As proposed, the development would endanger public safety by reason of a traffic hazard.
