

APPEAL by Tallaght Truck Park Limited care of Simon Clear of 46 Garville Avenue, Rathgar, Dublin against the decision made on the 18th day of November, 1999 by the Council of the County of South Dublin to refuse permission for development comprising the retention for a period of five years of truck park and ancillary containerised and open storage, access gates, control barriers, control building and perimeter fencing at Corbally, Blessington Road, Tallaght, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

1. It is considered that the proposed development, because it would lead to the creation of additional heavy goods vehicular turning movements on a heavily trafficked National Secondary Route (N81), would interfere with the safety and free flow of traffic on the route and endanger public safety by reason of traffic hazard and obstruction of road users.



Reasons

- The proposed development is located on the N81 which is a National Secondary Route. At the location of the proposed development, traffic flows are in excess of 20,000 vehicles/day which is in excess of the capacity of this road. The generation of additional HGV turning movements at this location would endanger public safety by reason of a traffic hazard.
- Frontal development along National Routes is contrary to the policy of both the National Roads Authority and the County Council. Section 2.6.6 of the South Dublin County Development Plan, 1998 states, "it is the policy of the Council to promote road safety and to avoid the creation of a traffic hazard". The proposed development would contravene a stated policy of the Development Plan.
- The proposed development is considered premature pending the construction and opening of the new National Route at this location.
