Reasons

- The proposed development does not meet the requirements of Section 3.4.16.i of the 1998 South Dublin County Development Plan which requires all houses to have a minimum of 60 sq. metres (exclusive of car parking area) of private open space behind the front building line.
- The proposed development does not meet the requirements of Section 3.4.19.i of the 1998 South Dublin County Development Plan which requires a minimum of 2.3 metres separation between the flank walls of each house.
- The proposed development does not meet with the requirements of Section 3.4.16.i of the 1998 South Dublin County Development Plan which requires a minimum standard of 22 metres between directly opposing first floor windows, the proposed roof-lighting being at first floor level. The proposed development would therefore, seriously injure the amenities of property in the vicinity.
