Reasons

- The proposed development constitutes undesirable ribbon 1 development on a substandard rural road network, which will lead to a demand for the uneconomic provision of services and would set an undesirable precedent for similar developments in the area.
- The site is within an area where the use zoning objective in the South Dublin County Development Plan 1998 is to protect and improve rural amenity and to provide for the development of agriculture. The zoning of the area requires that residential development be considered in accordance with Section 3.4.22 of the Development Plan. This section specifies the criteria to be met by applications for dwellings in rural areas. These include, design, road frontage, vehicular access, septic tank drainage, reservoir catchment and water supply. The proposed development does not satisfy all of the requirements in relation to the criteria for septic tank drainage. The proposed development would therefore be prejudicial to public health.
- The proposed development does not follow the Guidelines on 3 the Siting and Design of Rural Dwellings as per Appendix D of the South Dublin County Development Plan 1998. proposed development would, therefore, be contrary to the use zoning objective for the area in the Development Plan in that it would detract from rural amenity.
