

## Reasons

- The proposed advertising sign by virtue of its location and size would constitute excessive advertising on a site where there is already sufficient advertising in the form of an existing free standing sign advertising all facilities at this location. The proposed advertising structure would detract from the appearance of the site, would be unduly obtrusive and detrimental to the visual amenity of the area and would, accordingly, be contrary to the proper planning and development of the area.
- The proposed structure would be visible from a National Secondary Route (N81), would contribute to the creation of clutter on this site and would adversely affect the use of a national road by traffic and endanger public safety thereon by reason of distraction of drivers.
