Reasons

- Lack of off street car parking spaces would lead to additional on street car parking in front of shops where parking arrangements are haphazard. This would create serious traffic congestion.
- The proposed access laneway to the site of 4.1 metres width is unsuitable for the proposed development. The existing shopping area is already extremely restricted in its capacity to provide off street carparking facilities for this area. The proposed development would further exacerbate this situation and therefore would endanger public safety by reason of traffic hazard and obstruction to road users.
- The proposed development by reason of overdevelopment of the site and inadequate provision of facilities such as a public footpath and adequate private parking and private open space constitutes substandard development which would materially contravene the use zoning objective for the area in the South Dublin County Development Plan, 1998 'to protect and/ or improve residential amenity'.
- The applicant has demonstrated no consent of the relevant owner to his proposal to infill an existing window of another property and this is not an acceptable consequence of the proposed development.
- The proposed development would seriously injure the amenities and depreciate the value of property in the vicinity.
- The submitted plans and details contain insufficient and unsatisfactory information in respect of foul and surface water drainage and water supply. As such the proposal is prejudicial to public health.
