Reasons

- The proposed development, by reason of inadequate separation from adjoining properties and inadequate and poorly located private open space provision for the existing and proposed dwellings, would be substandard and would constitute overdevelopment of the subject site. The proposed development would therefore be contrary to the proper planning and development of the area.
- The proposed development, by virtue of the 6 no. dormer windows proposed, would result in an unacceptable level of overlooking of adjoining properties. The proposed development would therefore seriously injure the amenities of property in the vicinity and would materially contravene the zoning objective for the area which is "to protect and/or improve residential amenity".
- The proposed development, which makes no provision for off street parking facilities, would lead to on street parking which would endanger public safety by reason of traffic hazard and/or obstruction of road users.
- The proposed development may be prejudicial to public health as the applicant has not demonstrated that the proposed development provides adequate wayleaves from adjacent services.
