## Reasons

- The proposed development would be premature pending the determination by the Planning Authority/Roads Authority of a road layout for the area.
- The proposed development, by reason of the permanent access proposed via an estate road which currently has not been determined, on adjoining lands which are subject to Action Area Plans which have not been formulated, would be premature pending the determination of the development of the adjoining lands in accordance with approved action area plans, as required by Al zoning Objective for these lands "to provide for new residential communities in accordance with Action Area Plans". The proposed development would thus be contrary to the provisions of the South Dublin County Development Plan, 1998, and the proper planning and development of the area.
- The proposed development, by virtue of its architectural design, excessive height and bulk, and unsympathetic external treatment would be visually obtrusive and out of character in this rural location, and would not be consistent with the zoning objective of this area, which is Objective B 'To protect and improve rural amenity and to provide for the development of agriculture".
