## Reasons

- The proposed development comes within 5m of an existing 225mm foul sewer and a 150mm watermain which is not acceptable. The proposed development would therefore be prejudicial to public health, pose a mutual risk of damage to the proposed building and these services and leave insufficient room for repair, replacement or renewal of these services.
- The proposed development would encroach on the standard 2m set back from the roadside boundary which is required by the Council's Roads Department. The proposed development would therefore constitute substandard disorderly development and would be contrary to the proper planning and development of the area.
- The design of the proposed dwelling, having regard to its narrow frontage, would be seriously out of character with existing development and would be an obtrusive feature in the streetscape. The proposed development would therefore seriously detract from the amenities of property in the vicinity and would be contrary to the proper planning and development of the area.
