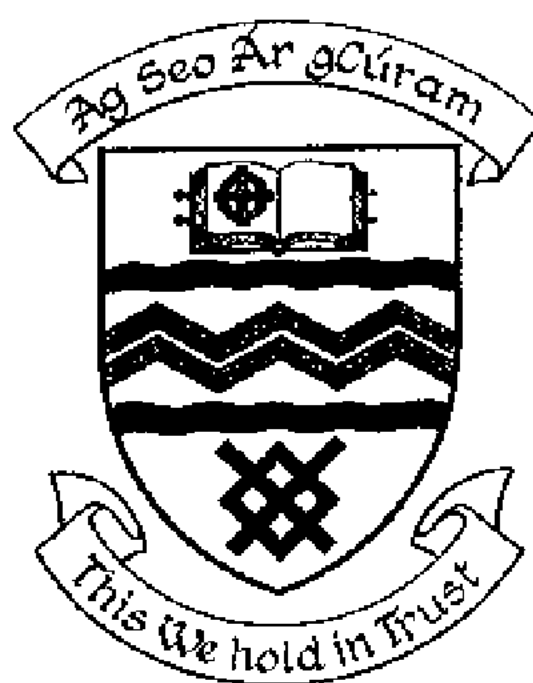

- 1 The applicants shall clarify how the proposal would comply with the parking standards of the South Dublin County Development Plan, 1998, with regard to on-site parking provision where 9 on-site car parking spaces are required.
- 2 The applicants shall clarify how it is intended to overcome the existing deficiency in vision splays, with regard to the height of the piers and walls, without compromising the integrity and character of the boundary treatment of this List 2 property.
