## Reasons

The proposed development, by reason of its scale, character, 1 materials and location within an area of high amenity and within and adjacent to the Lucan Bridge to Palmerstown Special Amenity Area and a proposed Natural Heritage Area, would be in serious contravention of the South Dublin County Development Plan, 1998, which seeks to preserve and enhance the character and special features of the area and to protect the natural beauty of the area. The proposed development, which would comprise of large expanses of palisade fencing and solid block walls, would represent a serious intrusion on the generally open, rural character of the area and would seriously injure the visual amenities of this highly sensitive area. Accordingly, the proposed development would contravene materially a development objective in the South Dublin County Development Plan, 1998, for the use solely or primarily of particular areas for particular purposes and would thus be contrary to the proper planning and development of the area.
