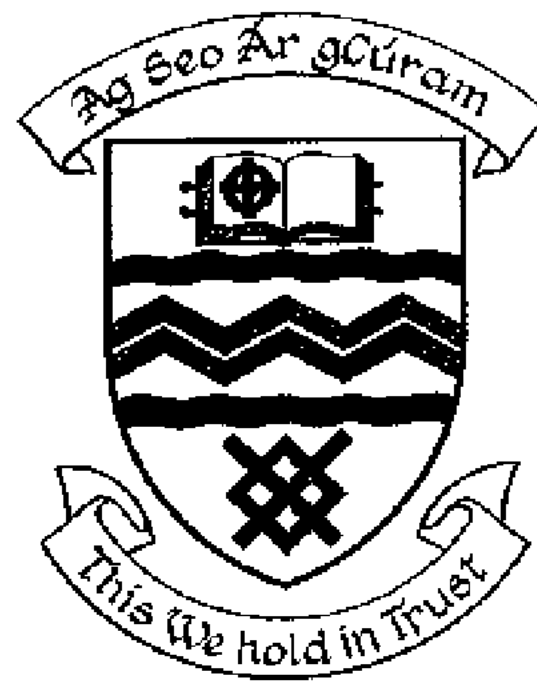

Reasons

- 1 The proposed development would result in piecemeal and poorly co-ordinated backland development and would be premature pending the adoption of an appropriate action plan for the area. It would therefore, be contrary to the proper planning and development of the area.
