

APPEAL by Cleargate Limited care of Feargall Kenny of 9 Village Crafts Centre, Cornelscourt, Dublin against the decision made on the 21st day of October, 1999 by the Council of the County of South Dublin to refuse permission for retention and completion of new palisade fencing to replace existing boundary wall and fence, including renewal of existing gates, at Colberts Fort, off Belgard Road, Tallaght, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the retention and completion of the said palisade fencing, including renewal of existing gates for the reason set out in the Schedule hereto.

SCHEDULE

Notwithstanding the poor visual condition of the existing boundary of the site adjoining Colberts Fort, it is considered that the provision of palisade fencing to replace the wall and gates would open up an industrial site to view from residential accommodation in the area. Visual separation from this accommodation is required in the interest of the maintenance of residential amenity. The development would seriously injure the residential amenities of adjoining property and would, therefore, be contrary to the proper planning and development of the area and would





Reasons

- The proposed site lies to the north of Colberts Fort Cottages. The proposed palisade fencing will be clearly visible from the cottages and allow clear views into the industrial site beyond. The proposed palisade fencing would be visually obtrusive at this location, would seriously injure the amenities of property in the vicinity and would be contrary to the proper planning and development of the area.
- It is considered that the traffic generated by the proposal to retain and upgrade the existing entrance gates on this sub-standard cul-de-sac which lacks a footpath on one side, would endanger public safety by reason of a traffic hazard.

With reference to your planning application, received on 31/05/99 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:


- The applicant is requested to indicate if planning permission was obtained for the existing gate as there are no Council records of such a permission. In this connection the Planning Authority is of the view that Colberts Fort road is not a suitable access for heavy commercial vehicles given its narrow width and the need to protect the residential amenity of properties on its southern side. Given that there appears to be an alternative access for heavy vehicles directly off the Belgard Road the applicant is requested to consider closing off the access from Colberts Fort. Revised drawings should be submitted to indicate how this can be achieved.
- The applicant is requested to indicate if there are any proposals to paint or otherwise colour finish the palisade fencing and to screen the yard from view from Colberts Fort.

 Again, the objective is to protect the residential amenities of the adjacent houses.
