Reasons

- The proposed development would contravene materially a development objective indicated in the South Dublin County Development Plan, 1998, for the use solely or primarily of particular areas for particular purposes i.e. zoning objective 'B' "To protect and improve rural amenity and to provide for the development of agriculture".
