

Reasons

- The site of the proposed development is in an area where it is a Development Plan objective to protect and enhance the outstanding natural character of the Dublin Mountain Area. The applicant has not demonstrated that he can overcome the restriction as set out in the South Dublin County Development Plan 1998 in respect of this zoning objective. The proposed development would contravene materially this use zoning objective indicated in the Development Plan and would therefore be contrary to the proper planning and development of the area.
- Taken together with existing development in the area, the proposed development would constitute undesirable ribbon development on a substandard rural road which would lead to demands for the uneconomic provision of services in a rural area and would set a precedent for further such development. By virtue of the above and the increased traffic turning movements likely to be generated by the proposed development, it is considered that the proposed development would endanger public safety by reason of a traffic hazard and would be contrary to the proper planning and development of the area.
- The proposed development being located on an elevated site would contravene materially the specific objective of the Development Plan which is 'to preserve views' and would be contrary to the proper planning and development of the area.
