

Reasons

- It is considered that the proposed development by reason of overlooking of the rear garden of the adjoining residential property will result in substandard development and as such would be seriously injurious to residential amenity and depreciate the value of the adjoining property.
- 2 Having regard to the existing carparking deficiency pertaining to the supermarket at ground floor level, it is considered that the proposed development would by reason of provision of inadequate carparking to comply with Development Plan standards, constitute overdevelopment of this restricted site.
- Having regard to the provision of inadequate private amenity space to comply with Development Plan standards, it is considered that the proposed development would constitute over development of this restricted site and as such would be seriously injurious to residential amenity and depreciate the value of property in the vicinity.
