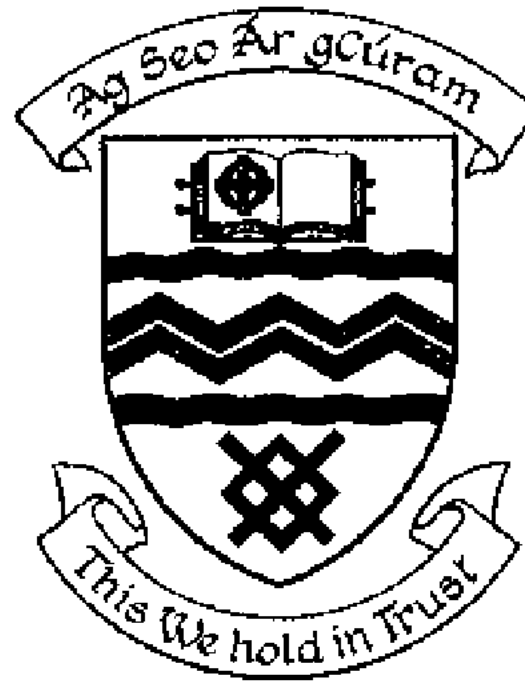

Reasons

- 1 The proposed development would endanger public safety by reason of traffic hazard due to the generation of traffic movements at a location where vision is extremely limited and where vision cannot be improved due to limited road frontage.
- 2 The proposed development would constitute undesirable ribbon development on a substandard rural road network, which would lead to a demand for the uneconomic provision of services and which would set an undesirable precedent for further similar developments in the area.
- 3 The site is located in an area which is zoned 'B' - in the South Dublin County Development Plan 1998, where it is the objective of the Planning Authority "to protect and improve rural amenity and to provide for the development of agriculture". It is Council policy, as stated at section 2.3.1 of the current Development Plan, to restrict the spread of one off houses into rural areas and dwellings will only be permitted on suitable sites where applicants can establish a genuine need to reside in close proximity to their employment where related to the rural community. It is considered that the proposed development does not conform to Council policy in this regard. The proposed development would therefore contravene materially the zoning objective for the area and, as such, would be contrary to the proper planning and development of the area.
- 4 The proposal to erect a dwelling on this sensitive and elevated site which is zoned "to protect and improve rural amenity and to provide for the development of agriculture" and where it is the stated objective of the Planning Authority to preserve views from the adjacent roadway, would be seriously injurious to the visual amenities of the area and, as such, would be contrary to the proper planning and development of the area.
