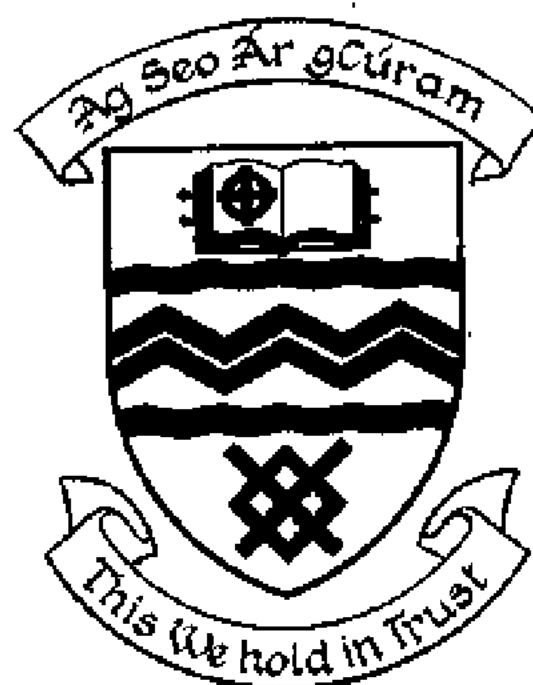

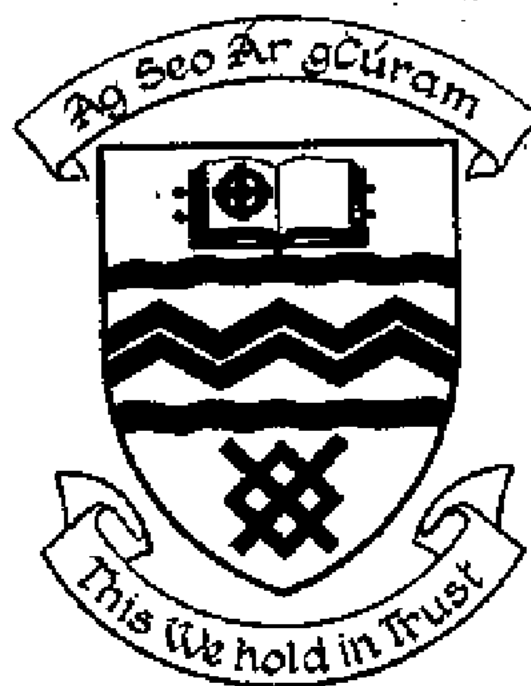

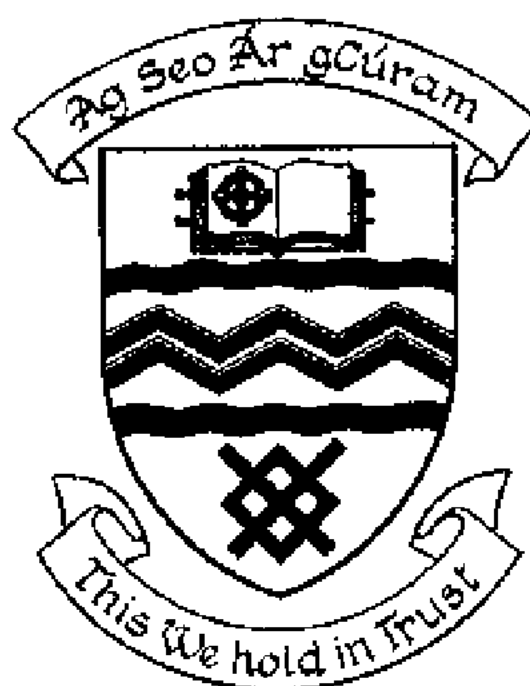

Reasons

- 1 Having regard to the loss of the existing screening vegetation along the common boundary and to the elevated position of the proposed house and balcony in relation to the adjacent cottage, it is considered that the proposed development would seriously injure the amenities of property in the vicinity by reason of undue overlooking and visual obtrusion. It would therefore contravene materially Zoning Objective A, ('To protect and/or improve residential amenity'), of the South Dublin County Development Plan 1989, and would not be in accordance with the proper planning and development of the area.
- 2 Having regard to the natural features and elevated nature of the site, its location on the boundary of the existing built-up and rural areas and adjacent to the designated Green Belt area, to the policy of the Council relating to trees and woodlands (Policy H24), and to the provisions of the South Dublin County Development Plan 1998, in particular development control objectives sections 3.2.1, 3.2.2, 3.3.2 and 3.4.1, it is considered that due to the substantial loss of existing tree cover and the lack of effective screening the proposed development would be visually obtrusive and seriously detrimental to the amenities of the area, and would not be in accordance with the proper planning and development of the area.

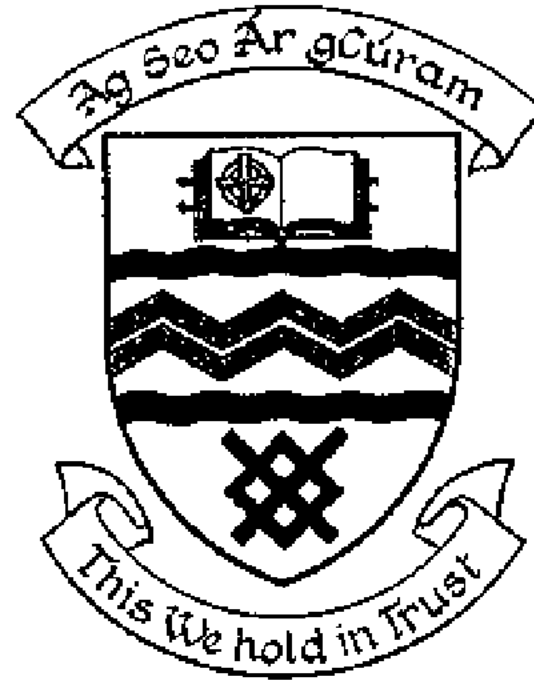

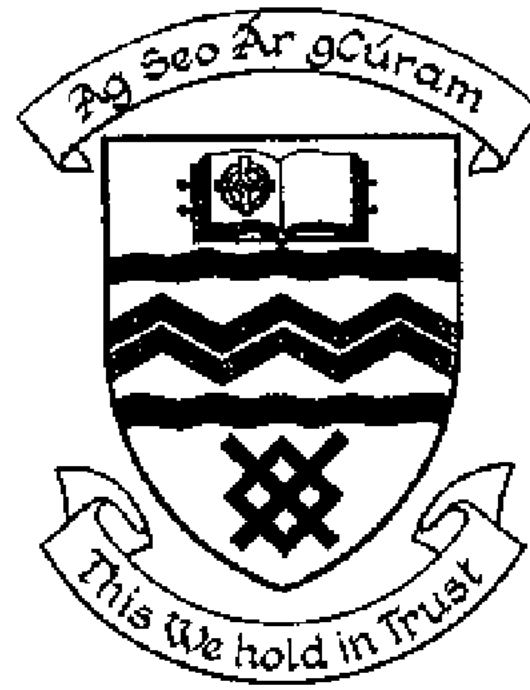
