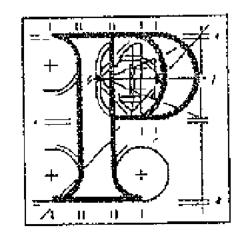
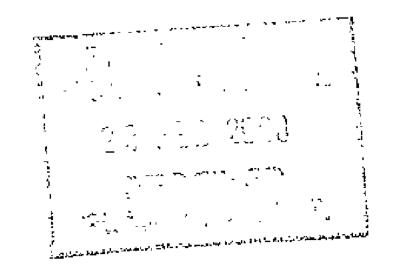

APPEAL by M. Gahan care of P. Murtagh of 31 Saint Killians Avenue, Greenhills, Dublin against the decision made on the 2nd day of July, 1999 by the Council of the County of South Dublin to refuse permission for development comprising the erection of a two-storey tiled roof house in front/side garden of 2 Saint Brendan's Crescent, Greenhills, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reason set out in the Schedule hereto.

SCHEDULE

Having regard to the limited area of the site and to the requirements of the planning authority regarding the provision of private open space, as stated in the current Development Plan for the area, it is considered that the proposed house would consistute overdevelopment of a restricted site, would result in the inadequate provision of private open space for the existing and proposed house, would seriously injure the residential amenities of the area and would, therefore, be contrary to the proper planning and development of the area.

Reasons
