1. Applicant to submit detailed plans showing the proposed seating layout of the upstairs lounge and the uses to which this lounge area will be put.
2. Details of colours and intensity of lighting for the proposed illuminated signs.
3. Clarification is required of the meaning of the rectangular markings shown in the lounge area on the first floor.
