

APPEAL by Rocco Macari and others care of Pro Urban Designs Limited of 50 River Forest View, Leixlip, County Kildare against the decision made on the 24th day of September, 1999 by the Council of the County of South Dublin to grant subject to conditions a permission to Saint Aengus Community Action Group care of Michael Duff of 26 Saint Aengus Crescent, Tymon North, Tallaght, Dublin for development comprising the construction of a new community drugs drop in centre adjacent to Saint Aengus Community Centre, Castletymon, Tallaght, Dublin in accordance with plans and particulars lodged with the said Council:

**DECISION:** Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, it is hereby decided, for the reason set out in the First Schedule hereto, to grant permission for the said development in accordance with the said plans and particulars, subject to the conditions specified in the Second Schedule hereto, the reasons for the imposition of the said conditions being as set out in the said Second Schedule and the said permission is hereby granted subject to the said conditions.

#### FIRST SCHEDULE

Having regard to the zoning objective for the area as set out in the current South Dublin County Development Plan, "to protect, provide for and/or improve local centre facilities", and the pattern of development in the area, it is considered that, subject to compliance with the conditions set out in the Second Schedule, the proposed development would not seriously injure the amenities of the area, and would not be contrary to the proper planning and development of the area.

### SECOND SCHEDULE

1. The development shall be carried out in accordance with the plans and particulars lodged with the application as amended by the drawings received by the planning authority on the 31st day of August, 1999, except as may otherwise be required in order to comply with the following conditions.

Reason: In the interest of clarity.

2. Water supply and drainage arrangements, including the disposal of surface water, shall comply with the requirements of the planning authority for such works and services.

Reason: In the interest of public health and to ensure a proper standard of development.




