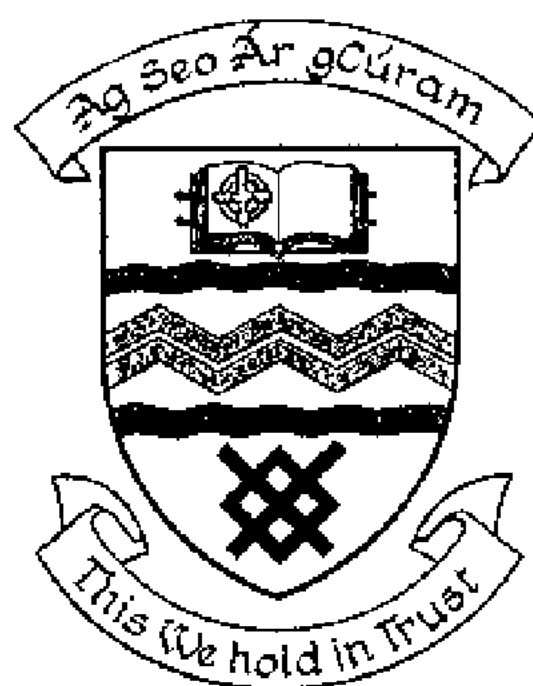

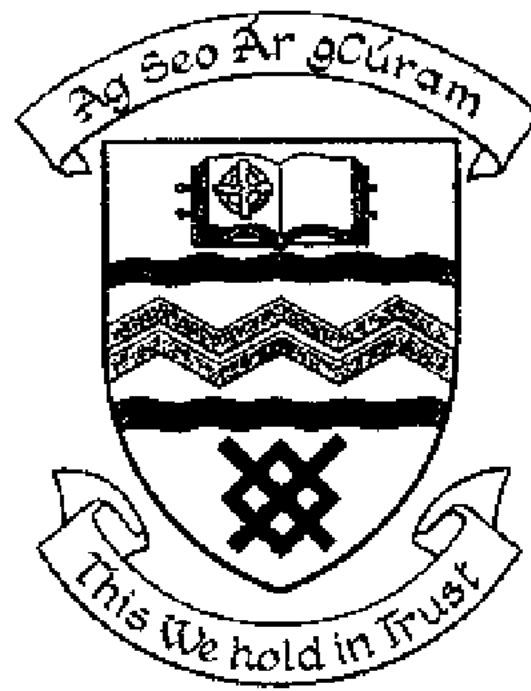

Reasons

- 1 Having regard to the fact that the subject site is located on the central reservation of a public road, it is considered that the applicant does not have sufficient legal interest in the site to carry out the proposed development.
- 2 It is considered that the proposed sign would confuse/distract drivers and as such would endanger public safety by creating a traffic hazard.
- 3 The proposed sign is located on the reservation for the proposed LUAS track.
- 4 It is considered that the proposed sign would contravene Development Plan policy with respect to advertising signage, specifically policy 3.6.4.ii which relates to advertising signage in public areas.
