- The proposed development would be premature by reference to the existing deficiency in the capacity of the foul sewerage system 1. serving the area and the period within which this constraint can reasonably be expected to cease.
- Adequate car parking spaces have not been provided within the curtilage of the site and, therefore, the proposed development would 2. result in on-street car parking and tend to create serious traffic congestion on Main Street.
- Having regard to the location of the site and to its relationship to adjoining property, it is considered that the proposed development, 3. because of the height and distribution of house blocks on the site, would result in overlooking of adjoining property and provide for inadequate open space distribution to serve the development. The proposed development would, therefore, seriously injure the amenities of the area and be contrary to the proper planning and development of the area.

Reasons

- The proposed development would represent poor standard piecemeal development on a single site within a substantial area of land zoned for development between Main Street, Rathcoole, and the Naas Road and, as such, would be contrary to the proper planning and development of the village. The area requires a comprehensive approach that would identify a suitable, limited number, of accesses off Main Street and that would generate development that would contribute positively to the development of the village and protect the amenities of existing properties.
- Development of the kind proposed on the land would be premature by reference to the existing deficiency in the capacity of the foul sewerage system serving Rathcoole and the period with in which this constraint can reasonably be expected to cease. There is insufficient capacity for any additional hydraulic loading in the local sewage treatment works.
- The proposed development would seriously injure the amenities of residential property in the vicinity through excessive overwooking from Block B of the adjacent bungalow to the west.
- The proposed public open space within the development is not properly distributed for the benefit of future residents.
- The proposed development would tend to create serious traffic congestion in the village due to a serious deficiency in the provision of on site parking spaces.
- The proposed development does not provide for proper integration with the recently installed traffic calming measures and street tree planting on Main Street. The entrance layout appears to provide for the removal of a tree on the street in front of the site and this would be contrary to the proper planning and development of the area.
- The application as submitted is inadequate in the following respects:
