Reasons

- By virtue of its narrow width and its siting well forward of the established building line at Bancroft Avenue, the proposed development would have a cramped and obtrusive appearance and would be inconsistent with the layout and character of the area. It would therefore seriously injure the residential amenity of property in the vicinity and would contravene materially the zoning objective for the area, which is "to protect and/or improve residential amenity.
- According to County Council records the proposed dwelling would be within 5 metres of a 100mm watermain which is not acceptable. The proposed development would be prejudicial to public health.
