Reasons

- The proposed access is onto the Blessington Road dual carriage way (the N81 National Secondary Route) and is adjacent to the Spawell Roundabout, as such it is considered that the additional traffic/turning movements generated would endanger public safety by reason of traffic hazard.
- The proposed development would contravene policy with respect to national secondary roads and with respect to traffic safety as set out in the South Dublin County Development Plan (specifically section 2.6.12.i), as such it is considered that the proposal would endanger public safety by reason of traffic hazard.
- The proposed development would materially contravene the zoning objective for the area indicated in the Dublin County Development Plan 1998, i.e. zoning objective G 'to protect and improve high amenity areas'.
- The proposed development would be prejudicial to public health by reason of the unsuitability of the soil for use as a percolation area and as such would be contrary to the proper planning and development of the area.
