## Reasons

- Having regard to the Roads Department's requirement for a 30 metre minimum setback along the National Primary Route and the fact that the development would infringe an existing building line along the N4 it is considered that the proposed development would be contrary to the proper planning and development of the area.
- Satisfactory evidence of the permission of the applicant to connect to the sewers and watermains serving the estate has not been submitted in support of the application. The proposed development would therefore be prejudicial to public health.
- Having regard to the fact that the proposed development would reduce the off street parking accommodation of the existing dwelling and that there would be inadequate road frontage to same to accommodate on street parking without obstructing other residents in the area, it is considered that the proposal would materially contravene a development plan objective regarding off street parking provision and would be seriously injurious to the amenities of property in the vicinity.
