Reasons

- The proposed extension would be less than 2 metres from 150mm diameter watermain to the north-east of the site and thus would be prejudicial to public health.
- Having regard to the size of the proposed development and the number of children to be accommodated it is considered that the proposal would materially contravene the zoning objective, "to protect and/or improve residential amenity" and would be contrary to the policy of the Council in relation to home-based economic activities, as set out in paragraph 2.2.8 of the South Dublin County Development Plan, 1998 and would be contrary to the proper planning and development of the area.
- Having regard to the number of children to be accommodated the resultant noise levels from same and the potential vehicular movements to and from the site, the proposal would seriously injure the amenities and depreciate the value of property in the vicinity.
