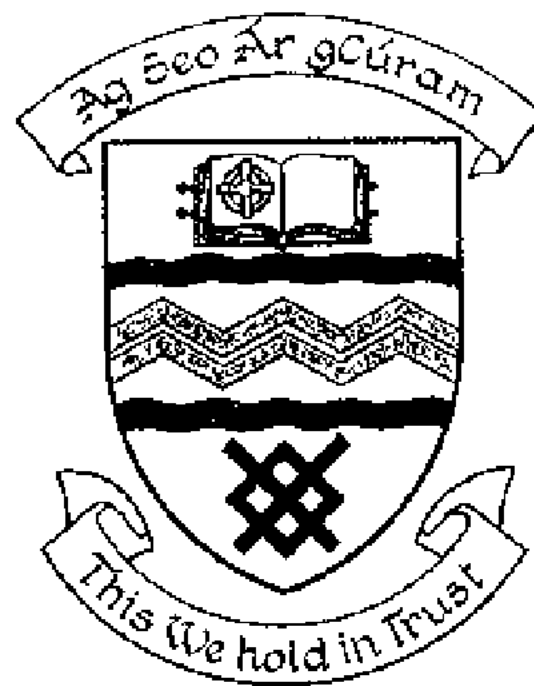

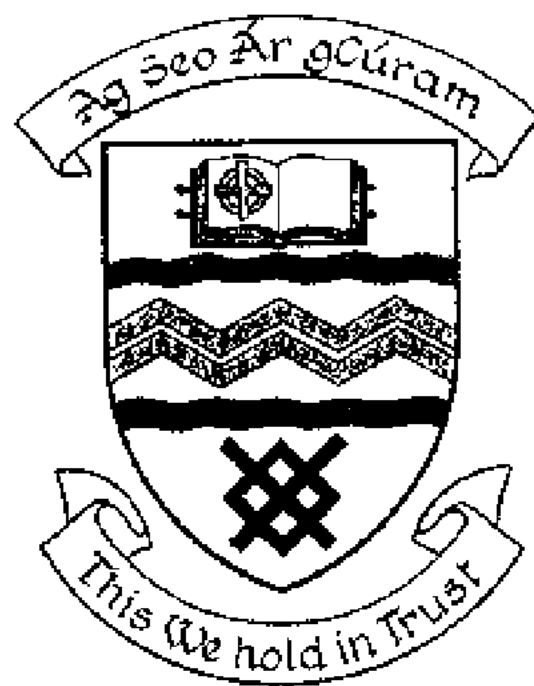
- 1 The applicant is advised that the surface and foul water sewers and watermain to which connection is proposed are not in the charge of the County Council. The applicant is requested to submit written evidence of the consent of the developer of the Willbrook Estate, in whose charge the services remain, to the connection of the proposed dwelling to same.
- 2 The applicant is requested to submit a detailed watermain layout indicating watermain sizes, valve, meter and hydrant layout up to and including connection to the public watermain.
- 3 The applicant is requested to submit details of proposed foul and surface water drainage including pipe sizes, gradients, cover and invert levels up to and including connection to the public sewers.
- 4 The applicant is requested to submit a revised site plan to a scale of not less than 1:200 accurately showing the existing driveway serving No. 8 Willsbrook Place detailing
