- (c) a statement of the date on which the notice is erected

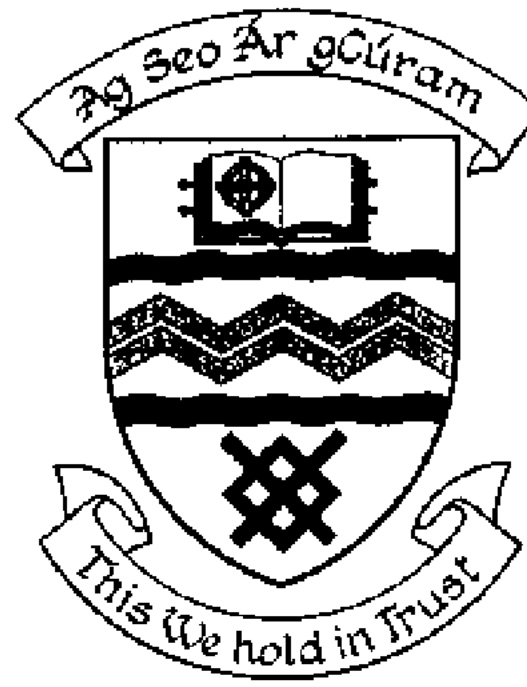
