

Reasons

- Having regard to the absence of adequate open space provision within the proposed development it is considered that the proposal would result in over development of the site and would materially contravene a development objective of the Dublin County Development Plan, 1993, with regard to open space provision and would be seriously injurious to the amenities of property in the vicinity.
- Having regard to the deficiency in the off-street car parking provision within the proposed development it is considered that the proposal would materially contravene a development objective of the Dublin County Development Plan, 1993, with regard to car parking provision and would be seriously injurious to the amenities of both the proposed one-bedroom units and other property in the vicinity.
- No details have been given of the foul drainage, surface water drainage and water supply which would serve the site.
- The introduction of multiple dwelling units into this area of single family dwelling units would be contrary to the proper planning and development of the area and seriously injurious to the residential amenities of the area.
- It is considered that the site notice and newspaper advertisement is misleading in that the proposed development represents two separate self-contained dwelling units rather than an extension to the existing dwelling.
