



With reference to your planning application, received on 07/09/98 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- The subject site incorporates an area to the front of the existing garage and to the side of the existing dwelling which appears to be in communal use and thus outside the applicant's ownership. 
