## Reasons

The design of the proposed development by virtue of the provision of utility and shower room and patio doors is considered to be inconsistent with the stated purpose for use as a household store. Furthermore it appears that the design of the structure is such that it could readily be used for the purpose of providing living accommodation. The provision of additional living accommodation within a detached structure located within the rear garden of the existing house is undesirable.
