Reasons

- The proposed extension, by virtue of its depth and height and its proximity to the adjoining house to the east, would result in an unacceptable level of overshadowing of and would be overdominent in relation to the house to the east. Furthermore, the windows at first floor level of the west elevation would result in an unreasonable level of overlooking of the adjoining property to the west.
