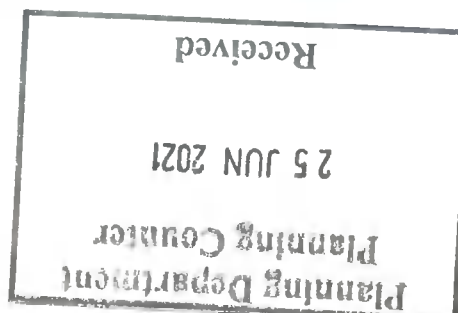

The development will consist of the construction of a gas fired power plant with an electrical output of up to 125MW with associated balance of plant, equipment and buildings including: an Engine Hall building with a height of 18.9m, (comprising 6 no. gas engines and ancillary infrastructure), an Electrical Annex Building with a height of 18.7m; a Workshop building with a height of 5.1m, a Tank Farm building with a height of 5.68m; a Security hut with a height of 3.27m; an Exhaust Stack with a height of 31.8m; a Gas AGI including a kiosk with height of 3.3m; Radiator Coolers with a height of 8.46m; 2 no. electrical transformers with a height of 4.98m; Tanks including 2 x Diesel Oil Storage Tanks (volume of 2500m³ combined); SCR Urea Tank (26m³); Lube Oil Storage Tank (26m³); Lube Oil Maintenance Tank (26m³); Pilot Oil Tank (26m³); Fire Water Storage Tank (1000m³); Effluent Collecting Tank (26m³); Underground Surface Water Attenuation Tank (490m³). The development will also include 2 no. new access onto the existing private road network with Profile Park; 12 no. number parking spaces, footpaths, landscaping; fencing and all other associated site development plant and equipment and other works including surface water and foul wastewater drainage.

An Environmental Impact Assessment Report has been completed for this development and is submitted as part of the planning application. The development also includes activities which are subject to an Industrial Emissions Licence from the Environmental Protection Agency. It should be noted in respect of this application that permission is sought for a period of 10 years.
