I, Gerry Teague, wish to apply for planning permission at a site of 0.168 ha at the Ball Alley House, Leixlip Road, Lucan, Co. Dublin. (A Protected Structure, South Dublin County Council RPS No. 094). The development consists of the following: the removal of selected hedging, the removal of the existing 52 No. car parking spaces and the construction of a 4-storey apartment building, with setbacks at third floor level, total 14 no. apartments comprising of; 1 no. one-bedroom, 11 no. two-bedroom and 2 no. 3-bedroom apartments. All with associated private open spaces areas in the form of balconies. With access to the development from existing vehicular and pedestrian entrance from Leixlip Road (R835) and from proposed new vehicular and pedestrian access from Ardeevin Drive.
