Alterations to previous approved planning application Reg. Ref. SD15A/0105. The proposed alterations consist of: (i) construction of a new single storey flat roof modular changing facilities (293 SQm) ancillary to the existing playing pitch; (ii) relocation of approved 38 no. carparking spaces and 2 no. coach parking bays from northern boundary to the eastern boundary adjacent to Cloverhill road (iii) installation of 6 no. new overhead flood lights; (iv) 3 no. new flag poles; (v) continuation of previously permitted boundary wall and footpath (Reg Ref.SD15A/010) extending along the south eastern boundary, with addition of new security fencing added to top of wall, all adjacent to Cloverhill road; (vi) new entrance gates (accessed via the permitted entrance off Cloverhill Road); (vii) all associated boundary treatment, landscaping and ancillary works necessary to facilitate the development at Cloverhill Road, Clondalkin, Dublin 22.
