Dear Planning Department Administrator.

As parents of a child registered to attend childcare in Ballyroan Community and Youth Centre from September 2021, we wish to oppose the proposed planning application Reference No. SD21A/0155. The construction of a giant 20 metre high radio mast just 2 meters from where my child will be playing on weekday's I believe could negatively impact his health and wellbeing.

The WHO/International Agency for Research on Cancer (IARC) has classified radiofrequency electromagnetic fields as possibly carcinogenic to humans (Group 2B), based on an increased risk for glioma, a malignant type of brain cancer¹, associated with wireless phone use. We believe that more research is necessary before taking a risk to locate this mast adjacent to a childcare and children's activities play area.
