To Whom it may concern

We would like to make a formal objection to the planning application SD21A/0179 at Ball Alley House, Leixlip Road, Lucan, Co. Dublin.

We are residents of Ardeevin Drive, where a proposed vehicular and pedestrian entrance and exit is being sought as part of this application. Having lived at this quiet and secluded cul de sac since 1976 we are on first name terms with most neighbours as well as being a part of the active residents association. It is of grave concern to us that this proposal would see increased traffic and footfall to what has for so long been a secure and closed one-way road. We also object to the fact that the proposed development, being 4 stories high would impact on the privacy of not only the surrounding houses but also of the whole road.

When Lucan Lodge Nursing Home opened in the late 1990's, the amount of traffic on the road increased dramatically and this is still the case. On a typical day during shift changes, it is not uncommon to have cars parked on both sides of the road, waiting to pick up staff members. The road is very narrow and this kind of parking is disruptive for residents as it is, never mind if additional traffic is added to the mix.

In terms of the pedestrian walkway, our concern lies in increased volumes of people gathering on the road when coming from the pub, thereby increasing the opportunity for anti-social behaviour. This is the same reason that the wall granting access to the car park was built up in the 1990's to avoid late night noise and adverse behaviour which had reached concerning levels.

Essentially, Ardeevin Drive is an established cul-de -sac and one of the selling points of the houses that exist there is the fact that it is not accessible via the busy Lucan Road. To change that purpose now would be detrimental to the whole ethos of the estate. There are many new and young families moving in to the estate now and we believe that this planning application would compromise the safety of children playing on the street, as well as congesting the whole road with traffic and thereby compromising the need to allow emergency vehicles in and out of the nursing home.

I trust that you will consider our objection.
