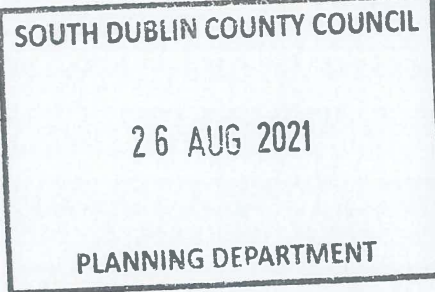

We have received your request for Further Information in relation to the above. Our client has applied to Irish Water for the pre-Connection Enquiry assessment.
