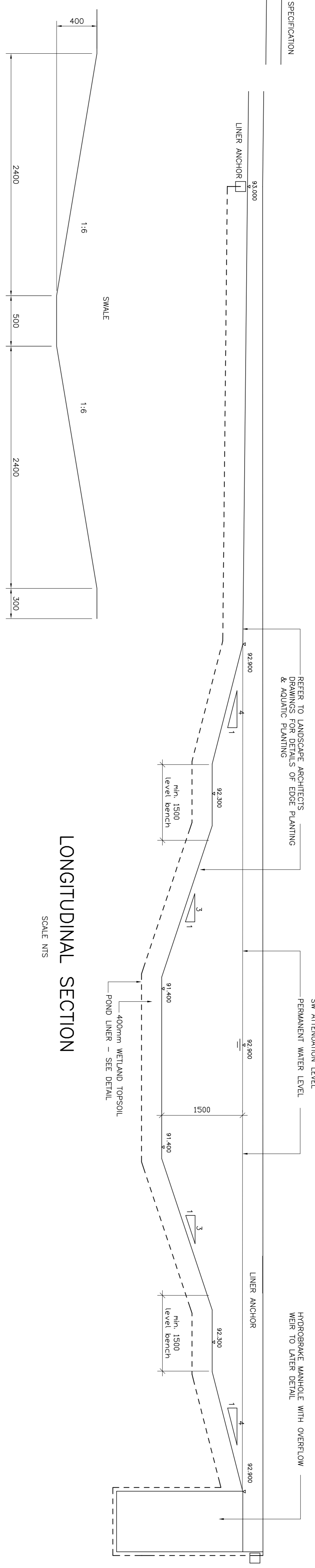

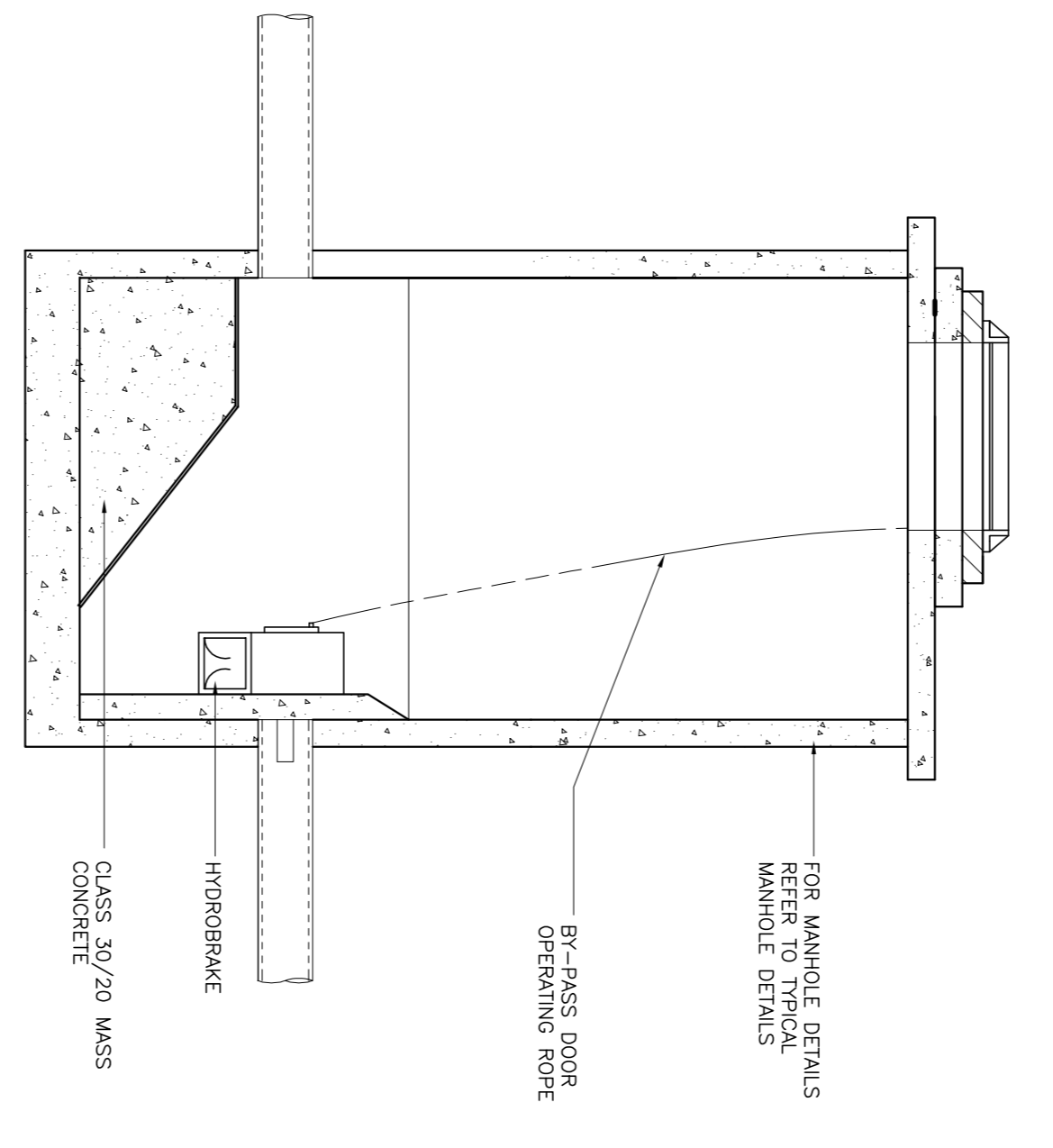

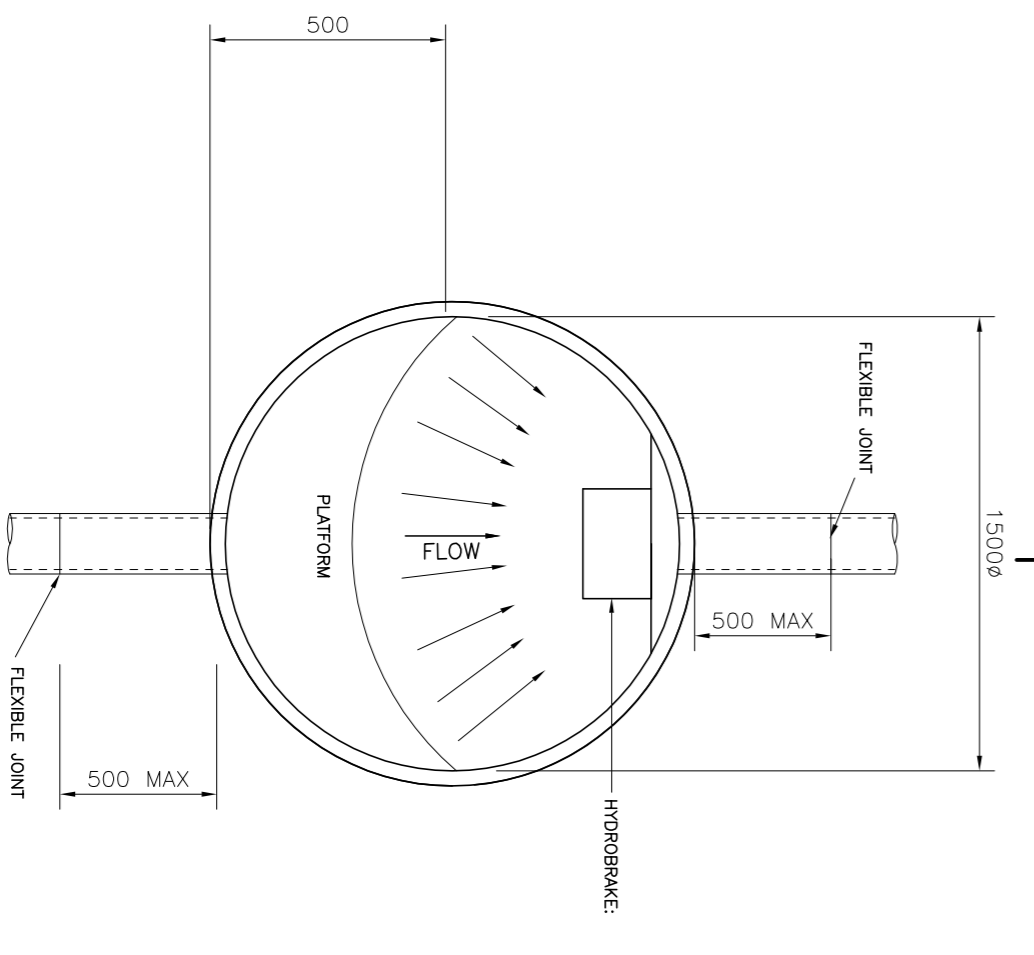


LONGITUDINAL SECTION
 SCALE N15

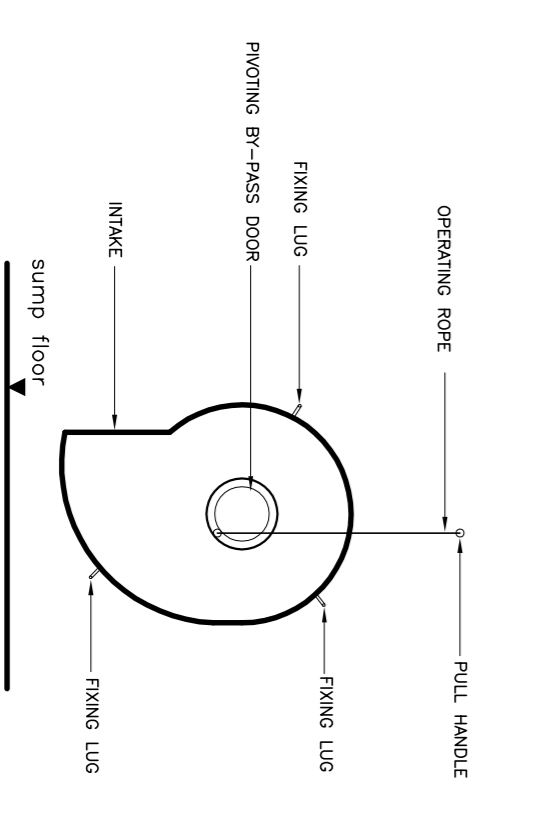
SWALE - CROSS SECTION
 SCALE 1:25



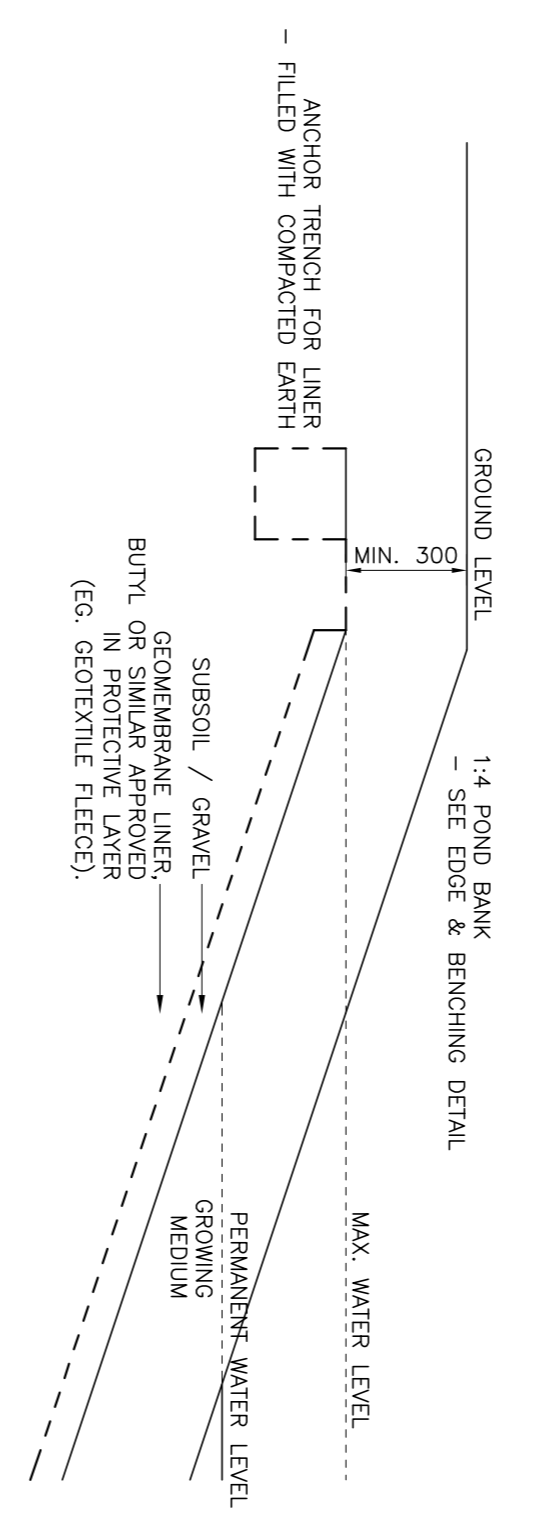
SECTION THRU

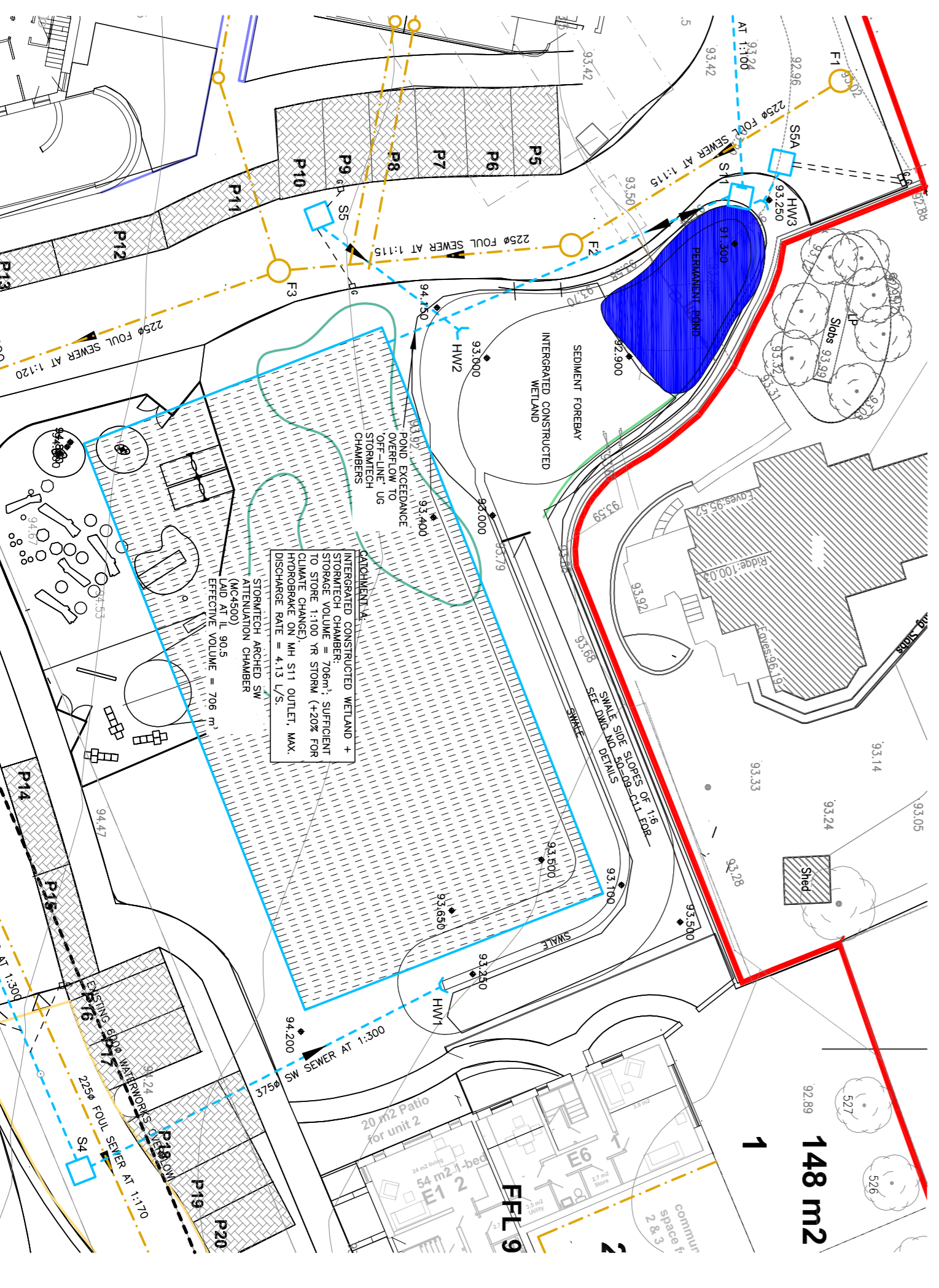
PLAN ON HYDROBRAKE
