SD19A/0264 comprising the omission of the 33 No. permitted Photovoltaic (PV) Solar Panels (53 sq m) to the ancillary office roof and the provision of 400 No. Photovoltaic (PV) Solar Panels (717 sq m) to the warehouse roof; the provision of an amended access arrangement including pedestrian and cyclist infrastructure to the staff/visitor carpark with the provision of an inter-com/FOB access point, central concrete aisle and gates; the omission of 1 No. permitted car parking space (reducing the quantum of car parking from 152 No. to 151 No. spaces); the provision of 2 No. sections of strip window glazing to the northern elevation of the warehouse (each 37.4 m in length and 1 m in height); the provision of a soft surface outdoor exercise area; boundary treatments and all associated development works above and below ground.
