The proposed amendments include: i) the erection of 2 no. bus shelters on Fonthill Road each comprising of a bus stop sign, real time passenger information (RTPI) unit and a two-sided internally illuminated advertising panel (c. 1.9sq.m each side); ii) road alterations on Fonthill Road comprising of the amendment of staggered to straight toucan crossings, the addition of a new straight toucan crossing, the replacement of bus layby areas with bus islands, and the removal of a left slip lane; and iii) all associated site services and site development works.
